LETTER OF DIRECTION

The Ontario Energy Board has now issued its Notice of Application and Hearing (the "Notice") with respect to the above matter.

You are directed:

- To immediately arrange for the publication of the Notice, together with the map, in the exact form accompanying this letter, except, under the second bullet of the section entitled "HAVE YOUR SAY" and under the heading "Oral and Written Hearings",
 - a. remove the bold and bracketed words "[insert actual date 10 calendar days from publication]"; and

- b. insert the actual date, using the following format "Month Day, 2014", which date shall be determined by adding 10 calendar days to the date of publication of the newspaper in which the Notice appears.
- 2. To file a *pdf* version of the completed Notice with the Board as soon as the dates as specified in the above paragraph are determined.
- 3. Publication must be made in one issue of the English language newspaper having the highest circulation, according to the best information available, in the Town of Amherstburg, Town of Essex, Town of Kingsville, Town of Lakeshore, Town of La Salle, Municipality of Leamington, Township of Pelee, Town of Tecumseh, the City of Windsor and in the service area of Entegrus Powerlines Inc.
- 4. To immediately arrange for the publication of the enclosed French version of the Notice, together with the map, in the exact form accompanying this letter, except, under the second bullet of the section entitled "DONNEZ VOTRE AVIS" and under the heading "AUDIENCE ORALE OU ÉCRITE"
 - a. remove the bold and bracketed words "[insérer la date correspondant à 10 jours calendaires suivant la publication du présent document]"; and
 - b. insert the actual date, using the following format "1 janvier 2014", which date shall be determined by adding 10 calendar days to the date of publication of the newspaper in which the Notice appears.
- 5. To file a *pdf* version of the completed Notice with the Board as soon as the dates as specified in the above paragraph are determined.
- 6. Publication must be made in one issue of the French language newspaper having the highest circulation, according to the best information available, in each of the designated areas in Essex County and Kent County. Note: Please make it clear to the newspaper that invoices regarding publication are to be sent to the applicants and not to the Board.

- 7. Conduct a search of title, sufficient to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the proposed line and facilities.
- 8. To serve a copy of each of the Notice and the Application, either personally, by courier, or by registered mail upon:
 - a. All directly affected property owners and encumbrancers with lands or interest in lands identified by the search of title referred to above;
 - All electricity distributors in whose service areas the proposed transmission facilities are or will be located, including the four distributors that may be impacted by the proposed cost allocation methodology;
 - c. All generators connected directly to the Hydro One Networks Inc. transmission line to which the proposed transmission facilities will connect;
 - d. All transmission customers of Hydro One Networks Inc. connected directly to the transmission line to which the proposed transmission facilities will connect;
 - e. All owners and operators of rail lines, telecommunications (e.g., telephone) or other utilities along or crossing the routes and locations proposed for the project;
 - f. The Clerks of all Municipalities that would be affected by the project;
 - g. All aboriginal communities that Hydro One Networks Inc. proposes to renotify as set out in Exhibit B/Tab 6/ Schedule 6/ page 2 of the pre-filed evidence;
 - h. The Community and Special Interest Groups listed in section 4.4 at Exhibit B/ Tab 6/Schedule 5 of the pre-filed evidence.
