By this letter, Toronto Hydro-Electric System Limited (“THESL”) requests Intervenor Status in the above-noted proceeding.

THESL is an electricity distributor operating under Licence ED-2002-0497. As a utility regulated by the Ontario Energy Board (the “Board”), THESL has a direct interest in all matters of jurisdiction, substance and procedure with respect to the regulation of electricity rates in Ontario, and in decisions of the Board which may affect THESL’s operation in the Ontario electricity market. THESL therefore has an interest in Hydro One’s current application to the Board, particularly the proposed rate model and framework, and the Board’s ensuing Decision and Order.
