Re: K2 Wind Ontario Limited Partnership; Application for Electricity Generation Licence; Response to the ACW Residents' Letter dated February 24, 2014 Board File No.: EB-2013-0439

We are writing on behalf of K2 Wind Ontario Limited Partnership ("**K2 Wind**") in response to a letter from certain residents of the Township of Ashfield-Colborne-Wawanosh (the "**ACW Residents**"), filed with the Board on February 24, 2014 (the "**ACW Residents' Letter**"). The ACW Residents' Letter is a "surreply" to K2 Wind's February 11th 2014 response ("**Response**") to the ACW Residents' January 31, 2014 submission on K2 Wind's application for a generation licence. We note that the Board's Notice of Application did not make provision for a surreply.

Notwithstanding the ACW Residents' Letter, K2 Wind maintains the positions it articulated in its original Response, generally, and specifically, with respect to the ACW Residents' submissions regarding delayed cost and compensation payments and pre-existing and long-standing drainage problems in the vicinity of Hydro One's switching station. K2 Wind expressly refutes the ACW Residents' new and unfounded allegations that Capital Power Corporation ("**Capital Power**"), K2 Wind and Kingsbridge 1 are engaging in a legal shell game. K2 Wind has no interest of any kind, directly or indirectly, in the Kingsbridge 1 project; nor is Kingsbridge 1 controlled by, or under common control with, K2 Wind. K2 Wind cannot and, indeed, has never purported to speak for Kingsbridge 1. That is precisely the reason why Kingsbridge 1 prepared the statutory declaration of Sandeep Sharma that was included in the K2 Wind Response. Finally and contrary to the assertion of the ACW Residents, Capital Power has not been appointed the operator of the K2 Wind project.



In conclusion, the evidence filed in this proceeding demonstrates that K2 Wind has the experience, knowledge and resources to own and operate the K2 Wind project in a safe and efficient manner. K2 Wind respectfully requests that the Board approve K2 Wind's application for an electricity generation licence.
