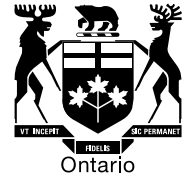

**Re: Application for Feed-in Tariff Program Electricity Generation Licence
Board File Number EB-2014-0054**

This will acknowledge receipt on February 27, 2014 of your application for an electricity generation licence as a Feed-in Tariff Program participant. The Board has assigned file number EB-2014-0054 to this matter. Your application is currently incomplete and cannot be processed until the following has been filed:

1. Sections 1 and 2, Pages 2 of the Application Form – Name to Appear on Licence and Feed-in Tariff Program Contract and Notice to Proceed:

In section 1 of the application form you have identified the legal name of the applicant as 2237116 Ontario Inc. and below requested that the name to appear on the licence be FotoLight LP. The application form notes that if the name to appear on the licence is different from the legal name, the legal name must appear first. Also the attached Notice to Proceed ("NTP") provides FotoLight LP as the legal name of supplier and has no reference to 2237116 Ontario Inc.

Please provide supporting documents to demonstrate that 2237116 Ontario Inc. is a general partner of FotoLight LP, or alternatively resubmit your application for FotoLight LP.

Section 2 of the application requires to provide details regarding the FIT contract with the OPA and the NTP. Information provided in this section does not match the information included in the attached NTP, specifically

- FIT reference No in the application form is FH1MZ56 while FIT contract No in the NTP is F-001561-SVP-130-505.

Please make applicable changes in section 2 and resubmit page 2 of the application form.

2. Section 10, Pages 6 of the Application Form – Licensing History:

Section 10 a) of the application requires to answer a question whether the applicant has ever been licensed by the Board. You have answered “Yes” and provided the licence No EG-2012-0393, however the name of the licensee appears to be different from the applicant’s name.

Please explain whether 2176050 Ontario Inc. has changed its name to the applicant’s name since the licence EG-2012-0393 has been issued. If yes, a licence amendment may be required instead of a new licence application. If the applicant is a separate legal entity from 2176050 Ontario Inc., the answer to question 10 a) should be “No”, the information about the licensee should be removed and page 6 resubmitted.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within **30 days** of the date of this letter, the Board may close the file for this application.

Upon receipt of the required information the Board will issue an acknowledgement letter indicating the expected date on which a decision and/or order may be rendered.
