After reviewing the K2 Wind submission dated February 27, 2014, the residents of ACW feel it is important for the following information to be brought to the Board's attention.

With regard to the obvious effort being made by K2 Wind to distance itself from the problems associated with Capital Power and the K1 Wind project and its problems, we submit the following for the Board's consideration:

1. <u>Appendix A</u> - Excerpts from K2 Wind response to OEB Staff interrogatories in EB-2012-0458.

The following statements should be noted.

Page 13 of 39 - "K2 Wind, through Capital Power (formerly EPCOR), has construction and operational experience with several relevant facilities..."

Page 14 of 39 - The Kingsbridge 1 Wind Operation is cited as a relevant facility.

Page 16 of 39 - "K2 Wind will rely on both internal corporate organizational capabilities (of its related companies) ... to complete the applied for transmission facilities." and "The K2 Wind partners will assign engineering and construction management staff to oversee the design and construction of the Proposed Facilities..."

Page 18 of 39 - "The K2 Wind partners expect to operate and maintain the Project, including the electrical facilities..."

2. Appendix B - Excerpts from the K2 Wind website: www.k2wind.ca.

The following statements should be noted:

K2 Wind Ontario - About Us: "K2 wind Ontario is a limited partnership between <u>Capital Power LP</u>, <u>Samsung Renewable Energy Inc</u>. and <u>Pattern Renewable Holdings Canada ULC</u>. The project team has come together to build and operate a 270-megawatt wind power farm in the Township of Ashfield-Colborne-Wawanosh."

K2 Wind Ontario - Contact Us: "Meetings with the K2 Wind Team are available upon request. Contact us for more details.

K2 Wind Ontario. c/o Capital Power 46 Victoria Street North Goderich, ON N7A 2R6 519.524.2760"

Their website clearly indicates that K2 Wind is a partnership between Capital Power and Pattern Energy and that the project team will build and operate the project. On the contact us page, it should be noted that the person shown on the left of the photo posted on the K2 Wind site is Dan Hayden, Operations Manager for K1 Wind. All contact information for the K2 Wind project is clearly directed to the Capital Power office in Goderich.

The K2 Wind contention that Capital Power and the K1 Wind project have no connection to K2 Wind or its project stands in direct contradiction to the connections outlined by K2 Wind in previous statements to the Board and on their own website. The Board's criteria for reviewing an application for a generating licence includes a review of past business history and conduct. This review should be thorough and broad enough to encompass the business history and conduct of partners that the applicant has stated will be involved in the operation of the project.

The residents stand by the problems and concerns outlined in our previous submissions to the Board.
