## Re: Webinar on the Implementation of the Scorecard for Electricity Distributors

The webinar will be transcribed to provide a prompt record of the session for distributors and to help facilitate preparation of FAQs following the session.

## Introductory Scorecards

To help electricity distributors prepare for the webinar, Board staff will send each distributor its own introductory Scorecard on **March 11, 2014**. It will present the five most recent years (i.e., 2008 to 2012) of available data for each measure. This Scorecard is being prepared for each individual distributor to provide a live example of how the Scorecard will look and is being provided for information purposes only.
