Distribution Inc. for an order or orders approving the final  
balances and for clearance of certain Demand Side  
Management Variance Accounts into rates, within the next  
available QRAM following the Board's approval.

### **PROCEDURAL ORDER NO. 5**

**March 11, 2014**

Enbridge Gas Distribution Inc. ("Enbridge") has filed an application with the Ontario Energy Board (the "Board") dated October 24, 2013 under section 36 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15, (Schedule B) (the "Act"), for an order or orders approving the final balances in certain 2012 Demand Side Management ("DSM") Deferral and Variance Accounts. Enbridge is also seeking the disposition of the balances in these accounts and inclusion into rates, within the next available Quarterly Rate Adjustment Mechanism following the Board's approval. The accounts which are the subject of the application and the balances recorded are as follows:

DSM Incentive Deferral Account	\$8,817,529 (to shareholder)
Lost Revenue Adjustment Mechanism Variance Account	(\$40,652) (to ratepayers)
DSM Variance Account	(\$303,490) (to ratepayers)

The net balance of the DSM Accounts is \$8,473,387 to be collected from ratepayers. Enbridge has also applied to the Board for such final and interim orders and/or accounting orders as may be necessary in relation to clearance of the accounts which

are the subject of this application. Enbridge further applied to the Board pursuant to the provisions of the Act and the Board's *Rules of Practice and Procedure* for such final and interim Orders and directions as may be necessary in relation to the application and the proper conduct of this proceeding.

On January 21, 2014, Enbridge filed a revised application due to inadvertent miscalculations in the original application that was filed on October 24, 2013.

The revised balances are as follows:

DSM Incentive Deferral Account	\$8,817,529 (to shareholder)
Lost Revenue Adjustment Mechanism Variance Account	(\$40,652) (to ratepayers)
DSM Variance Account	\$2,506,510 (to shareholder)

The net balance of the DSM Accounts is \$11,283,387 to be collected from ratepayers.

On February 21, 2014, the Board issued Procedural Order No. 4 that set-out the dates for submissions on the application and whether the information which is currently redacted should be made public.

Board staff has told the Board that the School Energy Coalition ("SEC") just received the unredacted materials on March 7, 2014 and SEC requires additional time to file its submission.

The Board will allow SEC additional time to file its submission.

A complete record of the proceeding is on the Board's website and at the Board's office.

At this time, the Board considers it necessary to make provisions for the following procedural matters. Please be aware that further procedural orders may be issued from time to time.

**THE BOARD ORDERS THAT:**

1. SEC may file final written submissions on the application and may include submissions on whether the information filed confidentially should remain confidential or be placed on the public record. The submission must be filed with the Board and copied to Board staff and all parties, on or before **March 14, 2014**.
2. Enbridge may file a written reply with the Board, and copy Board staff and all parties, on or before **March 28, 2014**.

All filings to the Board must quote file number EB-2013-0352 and be made electronically through the Board's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/> in searchable/unrestricted PDF format. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
