
**-: AFFIDAVIT OF SERVICE :-**

The Ontario Energy Board has issued its Decision and Order dated March 6, 2014 which approves the above-noted Franchise Agreement. Union now serves upon you a copy of the Decision and Order.

Union Gas received a package of documents from you dated January 29, 2014 which included 2 signed, but not sealed, copies of the Franchise Agreement and one photocopy of By-Law No. 2733-14 which was given third and final reading on January 27, 2014.

Union requires 4 original signed and sealed copies of the Franchise Agreement and 4 original signed and sealed copies of the By-law. **We also ask that you change the date in the second paragraph of the By-Law to identify the March 6, 2014 date of the Ontario Energy Board's Decision and Order.**

Enclosed are four (4) copies of the Franchise Agreement, one (1) photocopy of the By-law to authorize the Franchise Agreement as well as the two (2) copies of the signed Franchise Agreement that you originally sent to us. Union asks that you return the following documents to us:

- **four (4) original signed and sealed copies of the Franchise Agreement**
- **four (4) original signed and sealed copies of the By-law**

Since the Municipality has given the by-law third and final reading, the effective date of the Franchise Agreement will be the date of the Ontario Energy Board's Decision and Order (March 6, 2014).

Upon receipt of the above, Union Gas will execute the Franchise Agreement and return one (1) executed copy of the Franchise Agreement and corresponding By-law to your attention.
