Letter of Intervention of the Ontario Power Authority in EB-2013-0424 (Application for Amendment to Electricity Generator License EG-2009-0023)

On December 9, 2013, Greenfield South Power Corporation ("Greenfield South") applied to the Ontario Energy Board (the "Board") to amend its Electricity Generator License in order to relocate its facility from Mississauga, Ontario to St. Clair Township, Ontario. The Board assigned file number EB-2013-0424 to this matter on December 16, 2013.

The Ontario Power Authority ("OPA") was copied on a letter from counsel to Union Gas Limited ("Union") dated February 28, 2014 requesting intervenor status for Union in this proceeding. The OPA was also copied on Greenfield South's reply and objection to Union's intervenor status, sent by its counsel on March 7, 2014. However, the OPA was *not* copied on Union's most recent reply letter dated March 12, 2014.

In light of the OPA's Amended and Restated Clean Energy Supply ("ARCES") Contract with Greenfield South and its agreement with Greenfield South to relocate the facility to St. Clair Township, the OPA has a substantial interest in Greenfield South's license amendment application. Consequently, the OPA requests intervenor status in this proceeding in accordance with Rule 23 of the Board's *Rules of Practice and Procedure*.

The OPA requests, at minimum, to be copied on all future correspondence in this proceeding, and reserves its right to make further submissions to the Board if the OPA deems it necessary. The nature and the scope of the OPA's participation will depend on whether, and if so, how the Board decides to address the issues raised in the recent correspondence between Union and Greenfield South.
