Written Confirmation of Closing of Transfer of Generation Facilities and Request for Transferor Licence Cancellation.

By Decision and Order issued September 19, 2013 the captioned Met Fiera Solar project partnerships (Licencees) were each granted Electricity Generation Licences (EG-2013-0235, 0236 and 0240). The Decision and Order was premised on each of the Licencees acquiring from project entities owned by Recurrent Energy Lux Holdings S.à.r.l the following generation facilities, each as identified in the respective applications of each of the three Licencees:

1. Orillia 1, OPA Contract Identification Number F-000535-SPV-130-505.
2. Orillia 2, OPA Contract Identification Number F-000536-SPV-130-505.
3. Midhurst 4, OPA Contract Identification Number F-000586-SPV-130-505.

The Decision and Order provided in the case of each licence that:

1. The licence will become effective on the date upon which the licensee files with the Board an executed copy of the Ontario Power Authority's (OPA) *Assumption and Acknowledgement Agreement* in respect of the transferred facility, and a written confirmation that the commercial transaction has closed.
2. Schedule 1 of the Licencees' licence, which ordinarily describes the generation facilities for which the applicant is being licensed, will be completed when the Board receives written confirmation from the licensee that the commercial transaction that is the subject of the licence has closed and that the generation facility has been transferred to the licensee.

We are pleased to advise the Board that the commercial transactions for transfer of the generation facilities to each of the Licencees has now closed. Attached to this letter are, for each of the Licencees:

- (a) A signed confirmation from the licensee and the seller of the subject generation facility acknowledging closing of the commercial transaction, and transfer of the generation facility to the licensee.
- (b) A copy of the OPA's executed *Assumption and Acknowledgement Agreement* for the generation facility transferred.

In addition, through the attached confirmations, each of the sellers is also requesting, and has authorized us to file on its behalf its request for, cancellation of its Electricity Generation Licence (EG-2013-0088, EG-2012-0356 and EG-2012-0357).

Accordingly, in accord with the Decision and Orders referenced above, we request that the Board:

1. Confirm the effective date for each of generation licences EG-2013-0235, 0236 and 0240.
2. Issue completed licence Schedule 1s as follows:
 - (a) EG-2013-0235, listing the Orillia 1 generation facility, OPA Contract Identification Number F-000535-SPV-130-505.
 - (b) EG-2013-0236, listing the Orillia 2 generation facility, OPA Contract Identification Number F-000536-SPV-130-505.
 - (c) EG-2013-0240, listing the Midhurst 4 generation facility, OPA Contract Identification Number F-000586-SPV-130-505.
3. Cancel Electricity Generation Licences EG-2013-0088, EG-2012-0356 and EG-2012-0357.


