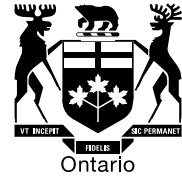

This will acknowledge receipt on April 2, 2014 of your application for a Gas Marketer licence. The Board has assigned file number EB-2014-0151 to this matter. Please refer to this file number in all future correspondence to the Board regarding this matter. All information related to this matter must be filed with the Board Secretary.

Your application is currently incomplete and cannot be processed until the following has been filed:

1. On page 9, section 12 "Finance" you have identified pro forma financial statements, a letter of reference from the applicant's bank and a general liability insurance as the items submitted in support of the applicant's financial position. In fact, a letter from RBC is the only document filed with your application. Based on previous experience with similar applications, the letter from the bank is not sufficient to evaluate financial viability of the applicant. Please provide pro forma financial statements for five years along with detailed notes or business plan explaining the assumptions used in preparing the pro forma statements. Pro forma statements as well as notes must be signed by one key individual.
2. Section 7(b) – Applications before the Ontario Energy Board

You have answered "No" to the question whether the applicant has any other applications before the Board. However, on March 14, 2014 you filed an

application for an electricity retailer licence (Board file EB-2014-0136). Please provide an appropriate answer to question 7 (b) and re-file Page 6 of the application form.

3. Section 15 - Documents to support identity

- a. The photocopy of the passport provided for Mr. Shoiry is chopped and does not have the issuance and expiry dates. Please provide a full copy of Mr. Shoiry's passport.
- b. You have provided a photocopy of Mr. Ness's passport which expired on February 14, 2014. Please provide a copy of a valid passport for Mr. Ness.
- c. You have provided a photocopy of Mr. Burke's passport which expired on July 9, 2013. Please provide a copy of a valid passport for Mr. Burke.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.

Please quote file number EB-2014-0151 when filing the additional information requested above. All filings should be directed to the attention of the Board Secretary.
