**Re: EB-2014-0139 – Jericho Wind, Inc. (“Jericho”) Section 41(9) Application (the “Application”) – Confidential Correspondence in respect of the Application**

We are legal counsel to Jericho in the above noted proceeding. On behalf of Jericho, we are hereby filing a request for the confidential treatment of a letter being filed by Jericho in respect of the Application (the “Confidentiality Request”). ### **Non-Confidential Summary**

The confidential information being filed is a letter updating the Board in support of a further request for an expedited hearing. In that update, we advise the Board that the Ministry of the Environment issued the REA for the Project on April 14, 2014, authorizing the construction and operation of the Project's distribution system (the "Distribution System"), among other things. Given that the REA has been issued, the letter indicates Jericho's intention to commence construction of the Distribution System promptly upon the Board issuing a Decision and Order in this proceeding or, in the alternative, the County of Lambton agreeing to the location of Jericho's Distribution System in County road allowances. The letter also describes why prompt construction of the Distribution System is critical to achieve Jericho's contractual commitments under its Feed-in-Tariff Contract with the Ontario Power Authority.
