Re: EB-2013-0174 - Veridian 2014 Rates - SEC Cost Claim

We are counsel for the School Energy Coalition. We enclose the cost claim of the School Energy Coalition, on the Board's form and enclosing docket details.

In this case SEC continued its practice of giving junior counsel Mark Rubenstein increasing responsibility. Mr. Rubenstein took the lead on this matter, and the involvement of senior counsel Jay Shepherd was limited to certain more complex policy issues, mainly during the ADR process.

It is submitted that the combination of broad responsibility for Mr. Rubenstein, at his lower cost, coupled with targeted involvement by Mr. Shepherd, at his higher cost, has produced, in this and other cases, an optimum result that keeps the overall cost down while seeking to maintain the most effective intervention possible.
