On April 3, 2014, Natural Resources Gas Limited ("NRG") filed an application with the Ontario Energy Board under the *Municipal Franchises Act* for an order approving the terms and conditions upon which, and the period for which, the Corporation of the Municipality of Thames Centre is, by law, to grant to NRG the right to operate works and add to works for the distribution of gas in the Municipality of Thames Centre for a period of 20 years. NRG also requested an order declaring and directing that the assent of the municipal electors is not necessary. The application has been assigned Board file number EB-2014-0153.

The application will be decided by the Manager, Natural Gas Applications, who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998*. The Manager, Natural Gas Applications, does not intend to provide for an award of costs when deciding the application.

How to Participate

All letters of comment will be placed on the public record, which means that the letters can be seen at the Board's offices and will be available on the Board's website. Before placing the letter of comment on the public record, the Board will remove any personal (i.e., not business) contact information from the letter of comment (i.e., the address, fax number, phone number, and e-mail address of the individual). However, the name of the individual and the content of the letter of comment will become part of the public record.
