NOTICE OF APPLICATION AND WRITTEN HEARING

APPLICATION FOR DETERMINATION OF LOCATION OF DISTRIBUTION FACILITIES WITHIN ROAD ALLOWANCES OWNED BY THE MUNICIPALITY OF KAWARTHA LAKES

The Application

Wpd Sumac Ridge Incorporated (the "Applicant") filed an application dated December 20, 2013 with the Ontario Energy Board (the "Board"), under subsection 41(9) of the Electricity Act, 1998, S.O. 1998, c. 15, Schedule A, as amended (the "Electricity Act") for an order or orders of the Board establishing the location of the Applicant's proposed distribution facilities within certain public roads (specifically Wild Turkey Road and Gray Road) owned by the Municipality of Kawartha Lakes (the "Municipality").

The Applicant is in the process of developing a 10.25 megawatt wind farm, called the Sumac Ridge Wind Project (the "Project"), in the City of Kawartha Lakes. The Project is being developed pursuant to a contract with the Ontario Power Authority under the Feed-in-Tariff program.

As part of the Project, the Applicant is proposing to construct a distribution system that will convey the electricity generated at the wind turbines to the local distribution system for delivery to the Independent Electricity System Operator-controlled grid. The distribution system is located on public and private lands.

As part of its distribution system, the Applicant is proposing to construct a 44kV underground collector line crossing beneath Wild Turkey Road and an aboveground 44 kV distribution line along Gray Road that will connect to an existing local distribution

system located along Highway 35 (collectively the "Distribution Facilities"). The Distribution Facilities are described in detail in the application at Exhibit C/ Tab 1/ Schedule 1. A map of potentially affected road allowances is appended to this Notice.

The Applicant states that it has not been able to reach an agreement with the Municipality with respect to the location of the proposed Distribution Facilities. Accordingly pursuant to subsection 41(9) of the *Electricity Act*, the Applicant requests that the Board issue an order determining the location of the Distribution Facilities within road allowances owned by the Municipality.

The Board has assigned File No. EB-2013-0442 to this application.

Scope Of This Proceeding

The scope of this proceeding is limited to determining the location of the Distribution Facilities within the road allowances owned by the Municipality. The consideration of any other aspect of the Project is not within the Board's jurisdiction.

The Board's jurisdiction in this proceeding arises from section 41 of the *Electricity Act*. Subsections 41(1), 41(5) and 41(9) read as follows:

- 41. (1) A transmitter or distributor may, over, under or on any public street or highway, construct or install such structures, equipment and other facilities as it considers necessary for the purpose of its transmission or distribution system, including poles and lines.
- (5) The exercise of powers under subsections (1), (2) and (3) does not require the consent of the owner of or any other person having an interest in the street or highway.
- (9) The location of any structures, equipment or facilities constructed or installed under subsection (1) shall be agreed on by the transmitter or distributor and the owner of the street or highway, and in case of disagreement shall be determined by the Board.


