DECISION AND ORDER ON COST AWARDS May 8, 2014

Background

On March 6, 2014 Union Gas Limited ("Union") applied to the Ontario Energy Board for an order effective April 1, 2014 to change its rates and other charges for the sale, distribution and storage of natural gas as set by the Board in EB-2011-0210 (Union's 2013 Cost of Service proceeding) and as most recently adjusted in EB-2013-0413 (Union's previous Quarterly Rate Adjustment Mechanism ("QRAM") proceeding).

On March 21, 2014, the Board issued its Decision and Order, in which it set out the process for intervenors to file their cost claims, for Union to object to the claims and for intervenors to respond to any objections raised by Union.

The Board received cost claims from the Canadian Manufacturers & Exporters ("CME") and the Industrial Gas Users Association ("IGUA").

On April 2, 2014, Union filed its response to the cost claims filed and stated that it had no objections to the cost claims from CME and IGUA.

Board Findings

The Board has reviewed the cost claims of CME and IGUA. The Board finds that both parties that have filed cost claims are eligible for 100% of the incurred costs of participating in this proceeding. The Board finds that both claims are reasonable and each of these claims shall be reimbursed by Union.

THE BOARD THEREFORE ORDERS THAT:

1. Pursuant to section 30 of the Ontario *Energy Board Act, 1998*, Union shall immediately pay the following amounts to the intervenors for their costs:

Canadian Manufacturers & Exporters

\$1,296.68; and

Industrial Gas Users Association

\$1,904.59.

2. Pursuant to section 30 of the Ontario *Energy Board Act, 1998*, Union shall pay the Board's costs of and incidental to, this proceeding immediately upon receipt of the Board's invoice.
