Horizon Utilities Corporation has applied to raise its electricity distribution rates.

Horizon Utilities Corporation has applied to the Ontario Energy Board (the "OEB") to adjust the amount it charges each month for electricity distribution beginning January 1, 2015 and continuing for a 5 year period to December 31, 2019. See the table below for a summary of the proposed monthly bill increases for a typical residential customer using 800 kWh per month:

2015	\$1.08
2016	\$1.38
2017	\$0.60
2018	\$0.41
2019	\$0.91

Other customers, including businesses, may be affected as well.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The OEB will hold a public hearing to consider Horizon's request. We will question the company on its case for a rate increase. We will also hear arguments from individuals and from groups that represent Horizon's customers. At the end of this hearing, the OEB will decide what, if any, increase will be allowed.

Distributors typically apply for a full review of their rates every five years with any rate changes for the years in-between automatically tied to inflation (and other factors intended to promote efficiency). In this application, Horizon is applying for a full review of their distribution rates over each of the five years, consistent with the option available under the Board's Renewed Regulatory Framework for Electricity for a distributor to file an application on a custom basis.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process. You can:

- Review Horizon's application on the OEB's website now.
- Sign up to observe the proceeding by receiving OEB documents related to the hearing.
- File a letter with your comments, which will be considered during the hearing.
- Become an active participant (called an intervenor). Apply by [insert actual date 10 calendar days from publication] or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, review the OEB's decision and its reasons on our website.

If you apply to become an intervenor, all information will be public.

This rate hearing will be held under section 78 of the Ontario Energy Board Act, 1998, S.O. 1998 c.15 (Schedule B).
