NOTICE OF APPLICATION

The Attawapiskat Power Corporation ("APC") filed an Application, dated December 1, 2006, with the Ontario Energy Board ("the Board") under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, Schedule B for an order that the current interim rates of APC be made final. The Board has assigned the application Board file no. EB-2006-0316.

APC's current rates were authorized on an interim basis by a Board order dated December 21, 2005 (Board file number EB-2005-0546). The interim rates were a continuation of rates authorized by a Board order dated October 14, 2005 (Board File number EB-2005-0233). APC proposes that these interim rates be made final and be in effect for the period January 1, 2006 to April 30, 2008.

Copies of the Application are available for public inspection at the Board's offices and at the offices of the Applicants.

If you wish to participate in this proceeding you **must**, within 10 days of the date of publication of this Notice, file a written request with the Board stating whether you wish to intervene, observe, or comment on this proceeding. If you intend to intervene in this proceeding, the Utility upon request is required to give you a copy of its submission and pre-filed evidence.
