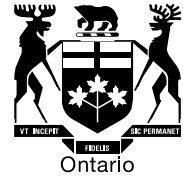

LETTER OF DIRECTION

Dear Mr. Miller:

**Re: Hydro One Brampton Networks Inc.
Application for 2015 Distribution Rates
Board File Number: EB-2014-0083**

The Ontario Energy Board has now issued its Notice of Application and Hearing relating to your 2015 cost of service distribution rates application (the "Notice"). Please note that you must publish the Notice within **fourteen days** of the date of this letter. If publication is not possible within fourteen days, you must inform the Board Secretary immediately.

You are directed:

1. To arrange immediately for the publication of the English version of the Notice, in the exact form accompanying this letter, except, under the fourth bullet of the section entitled "**BE INFORMED AND HAVE YOUR SAY**".
 - a. remove the bold and bracketed words "[insert actual date 10 calendar days from publication]"; and
 - b. insert the actual date, using the following format: "**January 1, 2014**", which date shall be determined by adding 10 calendar days to the date of publication of the newspaper in which the Notice appears.

Publication must be made in one edition of the Brampton Guardian.

Please note that invoices regarding publication are not to be sent to the Board.

To arrange immediately for the publication of the French version of the Notice, in the exact form accompanying this letter, except, under the fourth bullet of the section entitled "**SOYEZ RENSEIGNÉ ET DONNEZ VOTRE OPINION**"

2.

- a. remove the bold and bracketed words "[insérer la date, 10 jours suivant la date de publication]"; and
- b. insert the actual date, using the following format "**1 Janvier 2014**", which date shall be determined by adding 10 calendar days to the date of publication of the newspaper in which the Notice appears.

Publication must be made in one edition of Le Metropolitain.

Please note that invoices regarding publication are not to be sent to the Board.

3. To immediately file with the Board pdf versions of the completed English Notice and French Notice once the publication dates are known.
4. To immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on all intervenors of record in Hydro One Brampton Networks Inc.'s previous cost of service rate proceeding EB-2010-0132, namely:

Energy Probe Research Foundation
Power Stream Inc.
School Energy Coalition
Vulnerable Energy Consumers Coalition

5. If Hydro One Brampton Networks Inc. is a Host Distributor, to immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on its Embedded Distributor(s).
6. To place notification of both the English and French versions of the Notice and the application on your website.
7. To provide a copy of the application and evidence and any amendments thereto, on your website.
8. To make a copy of the Notice available for public review at Hydro One Brampton Inc.'s office.
9. To make a copy of the application and evidence and any amendments thereto, available for public review at Hydro One Brampton Inc.'s office.
10. To provide a copy of the application and evidence and any amendments thereto, to anyone requesting the material.

11. To file with the Board an affidavit proving publication and service of the Notice and that a copy of the application, evidence, and Notice are available for public review at Hydro One Brampton Networks Inc.'s office and on its website.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
