**NOTICE OF APPLICATION AND HEARING
ENBRIDGE GAS DISTRIBUTION INC.
LEAVE TO CONSTRUCT A NATURAL GAS PIPELINE IN THE CITY OF
BRAMPTON**

Enbridge Gas Distribution Inc. ("Enbridge" or the "applicant") has filed an application with the Ontario Energy Board (the "Board"), dated January 30, 2006, under section 90 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B). Enbridge has applied for an order of the Board granting leave to construct approximately 6.5 kilometres of 24 inch diameter steel natural gas pipeline (the "pipeline") in the City of Brampton. The proposed route of the pipeline will originate from the TransCanada Pipeline Ltd. pipeline on the south side of Sandalwood Parkway just west of Mountainash Road and proceed east along the south side of Sandalwood Parkway for approximately 1,000 metres to Airport Road. At Airport Road, the pipeline will proceed southeast along the south side of constructed and unconstructed sections of Humberwest Parkway for approximately 1,087 metres and cross Castlemore Road. The pipeline will proceed along the southwest side of the proposed Humberwest Parkway for approximately 1,718 metres and cross Williams Parkway. At Williams Parkway, the pipeline will proceed along Humberwest Parkway for approximately 1,542 metres and cross Queen Street East. The pipeline will then proceed along the west side of Goreway Drive and along the Goreway Electricity Generating Station ("Goreway Station") property boundary for approximately 1,170 metres to a point of interconnection with the Goreway Station. The Board has assigned the application File No. EB-2005-0539.

A map showing the location and route of the pipeline is included as Schedule A to this notice.

Construction of the pipeline is required to meet the future natural gas requirements of Goreway Station.

If approved, Enbridge plans to begin construction of the pipeline during the summer of 2006 and complete construction in the summer of 2007.

How to see Enbridge's Pre-filed Evidence

Copies of the application and the pre-filed evidence in support of Enbridge's application will be available for public inspection at the Board's offices, at Enbridge's head office and at the office of the City of Brampton.

How to Participate

You may participate in this proceeding in one of three ways:

You may send the Board a letter of comment. Your letter should include any request to make an oral presentation to the Board, and must be received by the Board no later than 30 days from the publication date of this notice.

You may request observer status in order to receive documents issued by the Board in the proceeding. Your request must be made by letter received by the Board no later than 10 days from the publication date of this notice.

You may request intervenor status if you wish to actively participate in the proceeding. Your request must be made by letter of intervention received no later than 10 days from the publication date of this notice, or, if you have been served this notice personally, no later than 10 days from the date of service. Your letter of intervention must include a description of how you are, or may be, affected by the proceeding; and if you represent a group, a description of the group and its membership. The Board may choose to hold either a written or an oral hearing. Your letter of intervention should indicate your preference for a written or oral hearing, and the reasons for that preference. The Board may order costs in this proceeding. You must indicate in your letter of intervention whether you expect to seek costs from the applicant and the grounds for your eligibility for costs. You must provide a copy of your letter of intervention to the applicant.
