NOTICE OF APPLICATION

UNION GAS LIMITED DISPOSITION OF 2013 DEFERRAL ACCOUNT BALANCES

Union Gas Limited (“Union”) filed an application dated May 2, 2014 with the Ontario Energy Board (the “Board”) under section 36 of the *Ontario Energy Board Act, 1998*, S.O. c.15, Schedule B, for an order of the Board approving the final disposition of 2013 year-end deferral account balances (the “Application”). The Application also requested the approval of a new Deferral Clearing Variance Account (Account No. 179-132). The Board has assigned file number EB-2014-0145 to the Application.

In this regard, Union is seeking various orders of the Board that, if granted, would result in the following estimated bill impact for the 6 month period October 1, 2014 to March 31, 2015:

- For residential customers in Union’s Southern Operations area, an estimated \$0.44 charge comprised of a delivery related charge of \$1.44 and a commodity related credit of \$1.00.
- For residential customers in Union’s Northern and Eastern Operations area, an estimated \$29.80 credit comprised of a delivery related credit of \$7.55 and a gas transportation related credit of \$22.25.

If you wish to give your opinion on the proceeding to the Board members hearing the application, you are invited to send a written letter of comment to the Board no later than **30 days** after the publication or service date of this notice. A complete copy of your letter of comment, including your name, contact information, and the content of the letter, will be provided to the applicant and the Hearing Panel. All letters of comment will be placed on the public record, which means that the letters can be seen at the Board's offices and will be available on the Board's website. Before placing the letter of comment on the public record, the Board will remove any personal (i.e., not business) contact information from the letter of comment (i.e., the address, fax number, phone number, and e-mail address of the individual). However, the name of the individual and the content of the letter of comment will become part of the public record. Please address your letter of comment to the Board Secretary at the address below, and reference file number **EB-2014-0145** at the top of your letter.

If you wish to actively participate in the proceeding (e.g. submit questions, file argument), you may request intervenor status from the Board, no later than **10 days** after the publication or service date of this notice.
