Ladies and Gentlemen:

**Re: Electricity Generation Licences (EG-2001-0065 and EG-2014-0048)**

This letter is being delivered in connection with:

1. Electricity Generation Licence EG-2001-0065, dated August 22, 2001, (“**Seller’s Licence**”) granted by the Ontario Energy Board (the “**OEB**”) to Algonquin Power Energy from Waste Inc. (which was formerly known as KMS Peel Inc. prior to a name change in 2003)(“**Seller**”); and
2. Interim Electricity Generation License EG-2014-0048, dated March 31, 2014 (“**Buyer’s Licence**”) granted by the OEB to Emerald Energy from Waste Inc. (the “**Buyer**”).

The purpose of this letter is to confirm that the Seller sold its interest in the generation facility listed on Schedule 1 of the Seller’s Licence (the “**Licensed Generation Facility**”) and sold its generation assets to the Buyer on April 4, 2014 (the “**Closing Date**”).

As the Buyer is the owner of the Licenced Generation Facility and the generation assets as of the Closing Date, the parties hereby request as follows:

1. the Seller requests that the OEB cancel the Seller’s Licence;
2. the Buyer and the Seller each request that the OEB transfer the Licensed Generation Facility from Seller’s Licence to Buyer’s Licence; and
3. the Buyer requests that the OEB issue a complete Buyer’s Licence with Schedule 1 populated with the details of the Licenced Generation Facility.


The undersigned request that the OEB proceed to hear and determine these requests in this regard without a hearing.
