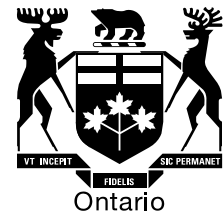

LETTER OF DIRECTION

Dear Ms. Hockin:

**Re: Union Gas Limited
Hagar Liquefaction Service Rate
Board File No. EB-2014-0012**

The Ontario Energy Board has now issued its Notice of Application and Hearing relating to your application seeking approval of rates for a new interruptible natural gas liquefaction service (the "Notice"). Please note that you must publish the Notice within **fourteen days** of the date of this letter. If publication is not possible within fourteen days, you must inform the Board Secretary immediately.

You are directed:

1. To immediately arrange for the publication of the Notice, in the exact form accompanying this letter, except under the fourth bullet of the section entitled **"BE INFORMED AND HAVE YOUR SAY"**.
 - a. remove the bold and bracketed words **"[insert actual date 10 calendar days from publication]"**; and
 - b. insert the actual date, using the following format **"January 1, 2014"**, which date shall be determined by adding 10 calendar days to the date of publication of the newspaper in which the Notice appears.

Publication must be made in one issue of a national English-language and French-language daily newspaper with the highest circulation in Union's franchise area.

Publication must also be made in one issue of the English-language and French-language daily newspapers, if available, and one issue of the English-language and French-language weekly newspapers, if available, having the highest circulation, according to the best information available in the following communities:

- Sudbury;
- North Bay;
- Markstay-Warren.

Please note that invoices regarding publication are not to be sent to the Board.

2. To immediately file with the Board a pdf version of the completed Notice once the publication date is known.
3. To immediately, and no later than the date of publication of the Notice, serve a copy of the Notice in both the English and French versions, together with a copy of the Application, either personally, by courier, or by registered mail on the Clerks of all municipalities in which Union Gas Limited ("Union") supplies gas.
4. To immediately, and no later than the date of publication of the Notice, if Union has not already done so, serve a copy of the Notice in the English version only, together with a copy of the Application, on:
 - a. any party to which Union sent information or with which Union had discussion about the proposed service, either as part of Union's non-binding call for Expressions of Interest as referenced in Union's application of May 16, 2014 or otherwise,
 - b. all First Nation Bands and First Nation Reserves to which Union supplies gas,
 - c. the Métis Nation of Ontario,
 - d. all intervenors in EB-2013-0365,
 - e. Enbridge Gas Distribution Inc.,
 - f. Natural Resource Gas Limited,

- g. the Ontario Trucking Association;
 - h. the Ontario Mining Association;
 - i. the Ministry of Transportation;
 - j. the Technical Safety Standards Association (Ontario); and
 - k. the Canadian Standards Association.
5. To make a copy of the application and evidence, and any amendments thereto, available for public review at Union Gas Limited's office and on its website.
6. To file with the Board an affidavit proving publication and service of the Notice and that a copy of the application, evidence and Notice are available for public review at Union Gas Limited's office and on its website.
7. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
