In light of this rescheduling, and the advice that we will not have the KPMG Report in time for the start of the hearing (sent in a separate letter), SEC will have to rethink its panel 1 cross. I will take a look at this on the weekend to see what can be done without the report, and I will advise on Monday.

A second issue has arisen now that we have looked at the detailed witness responsibility table. Panel 6 is responsible for no evidence or interrogatories, but Panel 7 is responsible for all of the evidence relating to cost of capital.

Please advise why all of the witnesses speaking to cost of capital are not being seated on the same panel.

Please be advised that a minor change is required to the scheduling of OPG's Witness Panels. This change is required to establish date certainty for an external witness on the Niagara Tunnel Panel, who is coming from California.

The Panels will be changed as follows:

- Overview Panel will take the stand first on June 10, as originally scheduled.
- At 09:30am on June 12, the Niagara Tunnel Panel will take the stand, regardless of whether the Overview Panel has been concluded or not.
- Upon completion of cross examination of the Niagara Tunnel Panel

(presumably on June 13), the Overview Panel will retake the stand (if their cross-examination was not completed on June 10) or the Hydroelectric Panel will take the stand.
