**Re: EB-2014-0168/170/172/179 – Copies of agreements assigning applicable OPA contracts**

We are counsel to Sombra Solar, LP, Moore Solar, LP, Varna Wind, LP and Kerwood Wind, LP (the "Applicants", and each an "Applicant").

On May 30, 2014, the Ontario Energy Board (the "Board") issued its Decision and Order in EB-2014-0168/170/172/179 (the "Decision and Order"). The Decision and Order authorized the transfer of:

- Electricity generation licence EG-2011-0022 from Sombra Solar, Inc. to Sombra Solar, LP;
- Electricity generation licence EG-2011-0023 from Moore Solar, Inc. to Moore Solar, LP;
- Electricity generation licence EG-2014-0011 from Varna Wind, Inc. to Varna Wind, LP; and
- Electricity generation licence EG-2013-0433 from Kerwood Wind, Inc. to Kerwood Wind, LP.

The Order stated that the above-noted electricity generation licences would be transferred once the Board received confirmation in writing that the OPA had assigned the applicable OPA contract(s) to each Applicant. Correspondence providing this confirmation was filed with the Board on June 11, 2014, June 12, 2014 and June 13, 2014.

On June 16, 2014, the Board requested that the agreements assigning the applicable OPA contract(s) to each Applicant be filed with the Board. A copy of each agreement is enclosed in the confidential version of this filing. The agreements are being submitted to the Board pursuant to the Board's *Practice Direction on Confidential Filings*. The need for confidentiality arises due to (i) the confidentiality obligations set out in the OPA contracts and (ii) the commercially sensitive information in the assignment agreements.
