**NOTICE OF APPLICATION FOR
DISPOSITION OF NON-COMMODITY DEFERRAL ACCOUNT BALANCES
NATURAL RESOURCE GAS LIMITED**

Natural Resource Gas Limited ("NRG") has applied to the Ontario Energy Board for an Order or Orders to dispense with the balances in the non-commodity related deferral accounts, as of September 30, 2006.

The non-commodity variance/deferral accounts that the company has are the Purchase Gas Transportation Variance Account ("PGTVA") and the Gas Cost Difference Recovery Variance Account ("GCDRVA").

The balance of the Regulatory Expense Deferral Account is \$155. NRG proposed that this account be carried forward for disposition at a later date.

The PGTVA had a total credit balance of \$87,287.86 as of September 30, 2006. It is proposed that this account be cleared by way of a one-time rebate to a typical residential consumer of \$7.12.

The balance of the GCDRVA is a debit of \$10,942. NRG proposed that this account be carried forward for disposition at a later date.

Participation

You may participate in this proceeding in one of three ways:

1. You may send the Board a letter of comment. Your letter must be received by the Board no later than 30 days from the date of this notice.
2. You may request observer status in order to receive documents issued by the Board in the proceeding. Your request must be made by letter received by the Board no later than 10 days from the date of this notice.

3. You may request intervenor status if you wish to actively participate in the proceeding. Your request must be made by letter of intervention received by the Board no later than 10 days from the date of this notice. Your letter of intervention must include a description of how you are, or may be, affected by the proceeding; and if you represent a group, a description of the group and its membership. The Board will hold a written hearing unless a party satisfies the Board that there is good reason to hold an oral hearing. If your letter of intervention indicates a preference for an oral hearing, please indicate your reasons. The Board may order costs in this proceeding. You must indicate in your letter of intervention whether you expect to seek costs from the applicant and the grounds for your eligibility for costs. You must provide a copy of your letter of intervention to the applicant.
