**NOTICE OF APPLICATION AND HEARING
ONTARIO POWER AUTHORITY
FISCAL 2007 PROPOSED EXPENDITURE AND REVENUE REQUIREMENTS
AND FEES SUBMISSION FOR REVIEW**

The Ontario Power Authority (the "OPA") has filed its fiscal 2007 proposed revenue requirements, expenditures and fees for review by the Ontario Energy Board (the "Board") in accordance with subsections 25.21 (1) and 25.21 (2) of the *Electricity Act, 1998*. The OPA was established by the *Electricity Restructuring Act, 2004*. The OPA's statutory objectives include ensuring an adequate, reliable and secure supply of electricity in Ontario.

The OPA is seeking the following approvals from the Board:

- 1) approval of an overall Operating Revenue Requirement of \$57.423 million;
- 2) approval of proposed 2007 capital expenditures of \$2.885 million;
- 3) approval to establish a usage fee of \$0.372/MWh;
- 4) approval of an Interim Fees Order effective January 1, 2007 in the absence of a final Order; and
- 5) approval to establish a 2007 Retailer Contract Settlement Deferral Account.

How to Participate

You may participate in this proceeding in one of three ways:

1. You may send the Board a letter of comment. Your letter should include any request to make an oral presentation to the Board, and must be received by the Board no later than **30 days** from the publication date of this notice.
2. You may request observer status in order to receive documents issued by the Board in the proceeding. Your request must be made by letter received by the Board no later than **10 days** from the publication date of this notice.
3. You may request intervenor status if you wish to actively participate in the proceeding. Your request must be made by letter of intervention received no later than **10 days** from the publication date of this notice, or, if you have been served this notice personally, no later than **10 days** from the date of service. Your letter of intervention must include a description of how you are, or may be, affected by the proceeding; and, if you represent a group, provide a description of the group and its membership. The Board may choose to hold either a written or an oral hearing. Your letter of intervention should indicate your preference for a written or oral hearing, and the reasons for that preference. The Board may order costs in this proceeding. You must indicate in your letter of intervention whether you expect to seek costs from the applicant and the grounds for your eligibility for costs. You must provide a copy of your letter of intervention to the applicant.
