Re: Ontario Power Authority - 2014 Revenue Requirement Submission Ontario Energy Board File No. EB-2013-0326

The Ontario Power Authority ("OPA") is writing to file its responses to the interrogatories of Board Staff and Intervenors.

The OPA wishes to note that a number of the interrogatories have raised issues which the OPA believes to be beyond the scope of this proceeding, particularly questions that ask about expenditures recovered through charges. The OPA has, in many cases, provided responses in an effort to be of assistance to the parties. The fact that the OPA has provided an answer to these interrogatories should not be taken as any indication that the OPA considers these areas of enquiry to be appropriate for the revenue requirement proceeding.
