PROCEDURAL ORDER NO. 1

Union Gas Limited ("Union") filed an application on May 16, 2014 with the Ontario Energy Board (the "Board") pursuant to section 36 of the *Ontario Energy Board Act,* 1998, S.O. c.15, Schedule B, for an order or orders approving a new interruptible natural gas liquefaction service. The Board has assigned the file number EB-2014-0012 to the Application.

Union has proposed to provide the new service at its Liquefied Natural Gas ("LNG") facility at Hagar, Ontario. Union has requested a new Rate L1 rate schedule and a cost-based rate to provide the service at Hagar. Union proposes to add new facilities adjacent to Hagar to provide LNG to wholesale distributors for use as motor vehicle fuel.

The Board issued a Notice of Application and Hearing on June 6, 2014. The last date for intervention was June 28, 2014. The following parties applied for intervenor status (* denotes a request for cost eligibility):

- Building Owners and Managers Association Toronto ("BOMA")*
- Canadian Manufacturers and Exporters ("CME")*

- Enbridge Gas Distribution Inc.
- Industrial Gas Users Association ("IGUA")*
- Northeastern Midstream LP
- Energy Probe Research Foundation ("Energy Probe")*

No objections were received regarding the requests for intervenor status or cost eligibility.

I have determined that all parties who requested intervenor status in this proceeding will be granted intervenor status. The list of intervenors in this proceeding is attached as Appendix "A" to this procedural order.

I have also determined that BOMA, CME, IGUA and Energy Probe are each eligible to apply for an award of costs under the Board's *Practice Direction on Cost Awards*.

I consider it necessary to make provision for the following matters related to this proceeding. The Board may issue further procedural orders from time to time.

IT IS ORDERED THAT:

- Board staff and intervenors who wish information and material from Union that is in addition to Union's pre-filed evidence with the Board, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to Union and all intervenors on or before July 22, 2014.
- 2. Union shall file with the Board complete responses to the interrogatories and deliver them to the intervenors no later than **August 12**, **2014**.

All filings to the Board must quote the file number, EB-2014-0012, be made electronically in searchable / unrestricted PDF format through the Board's web portal at https://www.errr.ontarioenergyboard.ca. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at http://www.ontarioenergyboard.ca/OEB/Industry. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two

paper copies. Those who do not have computer access are required to file 7 paper copies.
