NOTICE OF APPLICATION AND HEARING

GAS FRANCHISE APPROVAL AND APPROVAL TO ESTABLISH A CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY FOR THE TOWNSHIP OF ALFRED AND PLANTAGENET

Enbridge Gas Distribution Inc. (the “Applicant”) has filed an application dated May 12, 2006 with the Ontario Energy Board (the “Board”) under section 9 of the *Municipal Franchises Act*, R.S.O. 1990, c. M.55, as amended (the “Act”), for an order of the Board approving the terms and conditions upon which and the period for which the Corporation of the Township of Alfred and Plantagenet (the “Municipality”) is, by by-law, to grant to the Applicant the right to construct and operate works for the distribution of gas and the right to extend and add to the works in the Municipality. The Applicant has also applied for an order of the Board declaring and directing that the assent of the electors of the Municipality to the by-law is not necessary.

The Applicant has also, pursuant to section 8 of the Act, applied for an order of the Board that cancels or supersedes parts or all of the existing Certificates of Public Convenience and Necessity (“Certificates”) associated with the former entities within the Municipality and establishes a single Certificate.

On January 1, 1997, the former Township of Alfred, the former Township of North Plantagenet, the former Village of Alfred and the former Village of Plantagenet amalgamated to form the Municipality.

The Applicant currently holds Franchise Agreements and Certificates for the former entities of the Township of Alfred, the Township of North Plantagenet and the Village of Alfred. The Applicant does not hold a Franchise Agreement or Certificate for the Village of Plantagenet.

How to See the Applicant's Pre-filed Evidence

Copies of the application and pre-filed evidence will be available for public inspection at the Board's offices, the Applicant's offices, and at the office of the Municipality at the addresses indicated below.

How to Participate

You may participate in this proceeding in one of three ways:

1. You may send the Board a letter of comment. Your letter should include any request to make an oral presentation to the Board, and must be received by the Board no later than 30 days from the publication date of this notice.
2. You may request observer status in order to receive documents issued by the Board in the proceeding. Your request must be made by letter received by the Board no later than 10 days from the publication date of this notice.
3. You may request intervenor status if you wish to actively participate in the proceeding. Your request must be made by letter of intervention received no later than 10 days from the publication date of this notice, or, if you have been served this notice personally, no later than 10 days from the date of service. Your letter of intervention must include a description of how you are, or may be, affected by the proceeding; and if you represent a group, a description of the group and its membership. The Board may choose to hold either a written or an oral hearing. Your letter of intervention should indicate your preference for a written or oral hearing, and the reasons for that preference. The Board may order costs in this proceeding. You must indicate in your letter of intervention whether you expect to seek costs from the Applicant and the grounds for your eligibility for costs. You must provide a copy of your letter of intervention to the Applicant.
