Re: Request for Confidential Treatment of Information Associated with Great Lakes Power Transmission LP's Application for 2015 and 2016 Transmission Rates (EB-2014-0238)

We are counsel to Great Lakes Power Transmission LP ("GLPT") in respect of GLPT's Application for 2015 and 2016 Transmission Rates (EB-2014-0238) (the "Application"). The Application was filed on July 14, 2014.

In parallel with the filing of the Application and written evidence, on behalf of GLPT we are hereby filing a request for the confidential treatment of certain information which is intended to form part of the written evidence in support of the Application (the "Confidentiality Request"). This Confidentiality Request is being filed in accordance with the Board's *Practice Direction on Confidential Filings*.

The purpose of this Confidentiality Request is to protect the confidentiality of certain information that, if disclosed, would prejudice GLPT's load customers. Substantially the same type of information has received confidential treatment in prior rate applications.
