**NOTICE OF APPLICATION AND HEARING
UNION GAS LIMITED**

**LEAVE TO CONSTRUCT FOR THE SUPPLY TO THE ST. CLAIR
ENERGY CENTRE CONSISTING OF 7.4 KILOMETRES OF NATURAL
GAS PIPELINE AND ANCILLARY FACILITIES IN THE TOWNSHIP OF
ST. CLAIR AND IN THE COUNTY OF LAMBTON**

Union Gas Limited (the "Applicant") has filed an application with the Ontario Energy Board, (the "Board") dated October 2, 2006, under section 90 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15, Schedule B. The Applicant has applied for an order of the Board for leave to construct approximately 7.4 kilometres of steel natural gas pipeline in the County of Lambton. A portion of the proposed facilities, 4.5 kilometres of 20 inch pipeline, will originate at the Applicant's Petrosar Station at Lot 26, Concession 8, Township of St. Clair (formerly the Township of Moore) and then extend north to the Applicant's Dow Valve site at Lot 26, Concession 9, Township of St. Clair (formerly the Township of Moore). This portion of the facilities will generally follow Union's existing 12 inch Sarnia Industrial Line. The proposed facilities will also consist of 2.9 kilometres of 16 inch pipeline commencing at Union's Dow Valve site at Lot 26, Concession 9, Township of St. Clair (formerly the Township of Moore) and then extend east to the St. Clair Energy Centre at Lot 22, Concession 9, Township of St. Clair (formerly the Township of Moore), County of Lambton.

The Board has assigned File No. EB-2006-0237 to this Application.

A map showing the location of the proposed pipeline is included with this Notice.

The construction of the proposed pipeline will allow the Applicant to meet the natural gas requirements of the St. Clair Energy Centre.

In April 2005, the Ontario Government announced that St. Clair LP had been selected to develop and construct a 570 MW natural gas combined-cycle generation plant (the St.

Clair Energy Centre) at this location to provide electricity to the Provincial grid through a contract with the Ontario Power Authority.

The Applicant proposes to start construction no later than spring, 2007 and the planned in-service date for the project is November 1, 2007.

Copies of the application and the pre-filed evidence in support of the application will be available for public inspection at the Board's offices, at the Union Gas Limited head office and at the offices of the affected municipalities (addresses below).

How to Participate

You may participate in this proceeding in one of three ways:

You may send the Board a letter of comment. Your letter may include a request to make an oral presentation to the Board, and must be received by the Board no later than **30 days** from the publication date of this notice.

You may request observer status in order to receive documents issued by the Board in the proceeding. Your request must be made by letter received by the Board no later than **10 days** from the publication date of this notice.

You may request intervenor status if you wish to actively participate in the proceeding. Your request must be made by letter of intervention received no later than **10 days** from the publication date of this notice, or, if you have been served this notice personally, no later than **10 days** from the date of service. Your letter of intervention must include a description of how you are, or may be, affected by the proceeding; and if you represent a group, a description of the group and its membership. The Board may choose to hold either a written or an oral hearing. Your letter of intervention should indicate your preference for a written or oral hearing, and the reasons for that preference. The Board may order costs in this proceeding. You must indicate in your letter of intervention whether you expect to seek costs from the applicant and the grounds for your eligibility for costs. You must provide a copy of your letter of intervention to the applicant.

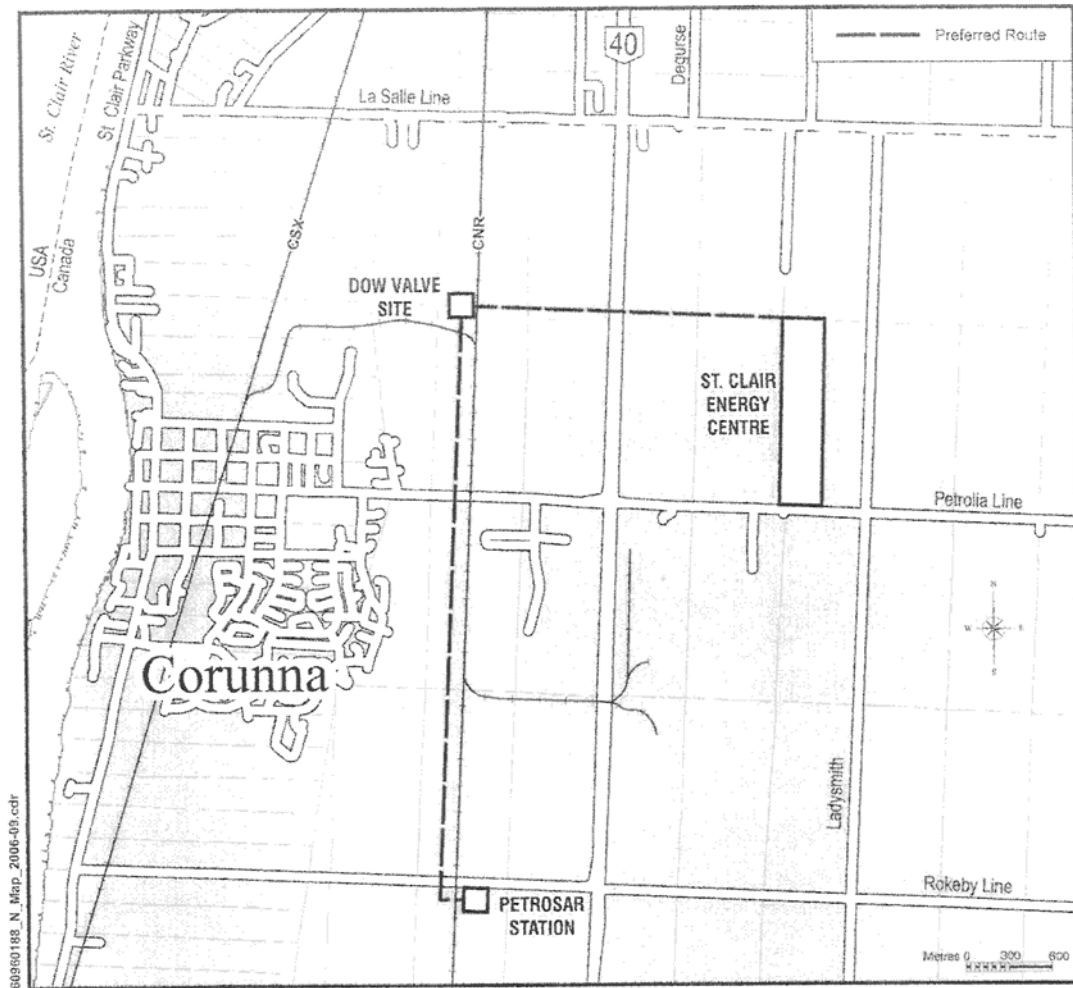
