

# ONTARIO ENERGY BOARD NOTICE TO CUSTOMERS OF ENBRIDGE GAS DISTRIBUTION INC.

**Enbridge Gas Distribution Inc. has applied  
for approval to dispose of certain account balances.  
Learn more. Have your say.**

Enbridge Gas Distribution Inc. has applied to the Ontario Energy Board for approval to dispose of amounts recorded in certain deferral or variance accounts which it says will have a one-time impact on your bill in the month of October 2014 in the following way:

- For residential customers served under Rate 1 an estimated \$0.10 credit.
- For commercial customers served under Rate 6 an estimated \$57 credit.

Other customers, including businesses, may also be affected.

## THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The OEB will hold a public hearing to consider Enbridge Gas Distribution's request. We will question the company on its case. We will also hear arguments from individuals and from groups that represent Enbridge Gas Distribution's customers. At the end of this hearing, the OEB will decide whether to approve all or any part of the request.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

## BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process. You can:

- review Enbridge Gas Distribution's application on the OEB's website now.
- file a letter with your comments, which will be considered during the hearing.
- become an active participant (called an intervenor). Apply no later than 10 calendar days after you are served directly with this notice, or, if you were not served directly with the notice, apply to be an intervenor no later than **July 28, 2014**. If you do not apply to be an intervenor, the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- at the end of the process, review the OEB's decision and its reasons on our website.

## ORAL VS. WRITTEN HEARINGS

There are two types of OEB hearings – oral and written. The OEB will determine at a later date whether to proceed by way of a written or oral hearing. If you think an oral hearing is needed, you can write to the OEB to explain why.

## PRIVACY

*If you write a letter of comment, your name and the content of your letter or the documents you file with the OEB will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.*

*This rate hearing will be held under section 36 of the Ontario Energy Board Act, S.O. 1998 c.15 (Schedule B).*
