**PROCEDURAL ORDER NO. 4**

**July 18, 2014**

Procedural Order No. 3, issued on July 15, 2014, established a schedule for the filing of submissions. Counsel for Prince Edward County has requested that all dates established in Procedural Order No. 3 be postponed by 2 weeks to accommodate a planned vacation and the unavailability of substitute counsel from his firm.

The Board will grant the requested postponement of the filing dates established in P.O. No. 3. The new dates are set out below.

**THE BOARD ORDERS THAT:**

1. The Applicant shall file its argument-in-chief, if any, with the Board and deliver it to all intervenors by **August 6, 2014**.
2. Board staff and intervenors shall file their submissions, if any, with the Board, and deliver it to the Applicant and all intervenors by **August 13, 2014**.
3. If the Applicant wishes to respond to any of the submissions, the response must be filed with the Board and delivered to all intervenors by **August 22, 2014**.

All filings to the Board must quote the file number, EB-2013-0339, be made through the Board's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. If the web portal is not available you may email your document to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
