- BCP is the sole customer in BPI's Embedded Distributor class;
- The service territory of BCP fully surrounds that of BPI; and
- BPI and BCP together comprise the Brant sub-region of the Burlington to Nanticoke Regional Infrastructure Planning area.

BPI intends to participate actively and responsibly in these proceedings in order to ascertain whether and how the Applicants' proposals impact BPI's electrical system, its customers, and its shareholder. BPI has reviewed the evidence and expects that its participation will, in the least, include the submission of interrogatories to the Applicants. BPI reserves the right to further participate as an intervenor in all aspects of these proceedings

BPI understands it is not eligible for costs awards in these proceedings, and does not intend to seek cost awards.
