- b. insert the actual date, using the following format "Month Day, 2014", which date shall be determined by adding 10 calendar days to the date of publication of the newspaper in which the Notice appears. If the date falls on a "holiday" as defined in Rule 6.02 of the Board's *Rules of Practice and Procedure*, insert the next date that is not a holiday.

 - f. All owners and operators of rail lines, telecommunications (e.g., telephone) or other utilities along or crossing the routes proposed for the project;
 - g. The Clerks of all Municipalities that would be affected by the project;
 - h. All Aboriginal communities with any interest in the lands affected by the project, including those listed in Exhibit G, Tab 1, Schedule 1, page 8 of the pre-filed evidence;
 - i. The following provincial government ministries and agencies:
 - (i) Ministry of Energy
 - (ii) Ministry of Economic Development, Employment and Infrastructure;

- 9. To immediately provide a copy of the Notice, the Application and the pre-filed evidence, and any additional materials as they are filed in the EB-2014-0194 matter, to any person upon request.
