

ONTARIO ENERGY BOARD NOTICE

Goldcorp Inc. has applied for an order regarding the responsibility for payment of certain costs related to the construction of a pipeline by Union Gas Limited.

Learn more. Have your say.

The Ontario Energy Board previously approved an application by Union Gas Limited to construct a natural gas pipeline to serve certain of Goldcorp Inc.'s mines. There was a delay in the construction which Goldcorp Inc. says resulted in additional costs. In the current application Goldcorp Inc. is asking the Board to order Union Gas Limited to exclude \$2,375,000 of the additional costs from Goldcorp's contribution in aid of construction for the natural gas pipeline.

THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The OEB will hold a public hearing to consider Goldcorp Inc.'s request. We will question both Goldcorp and Union Gas on the case. We will also hear arguments from individuals and from groups that represent Union Gas' customers. At the end of this hearing, the OEB will decide the appropriate amount payable by Goldcorp to Union Gas.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process. You can:

- review Goldcorp's application on the OEB's website now.
- file a letter with your comments, which will be considered during the hearing.
- become an active participant (called an intervenor). Apply no later than 10 calendar days after you are served directly with this notice, or, if you were not served directly with the notice, apply to be an intervenor no later than **[insert actual date 10 calendar days from the date the notice is posted on applicant's website]**. If you do not apply to be an intervenor, the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- at the end of the process, review the OEB's decision and its reasons on our website.

ORAL VS. WRITTEN HEARINGS

There are two types of OEB hearings – oral and written. The OEB will determine at a later date whether to proceed by way of a written or oral hearing. If you think an oral hearing is needed, you can write to the OEB to explain why.

PRIVACY

If you write a letter of comment, your name and the content of your letter or the documents you file with the OEB will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.

This rate hearing will be held under section 36 of the Ontario Energy Board Act, S.O. 1998 c. 15 (Schedule B).
