- c. Milton Hydro has provided the regular hours by department worked by Milton Hydro staff in the restoration effort in the following table. Milton Hydro would note that these hours apply to December 23, 2014. The ice storm occurred over the Christmas time period and included weekends and statutory holidays when Milton Hydro was closed. Milton Hydro does provide for a standby crew during the period when the office is closed and a standby rate is paid. This standby rate is **not** included in Milton Hydro's Z-Factor Application as it is paid whether the standby crew are called out to work or not.
