IN THE MATTER OF the *Ontario Energy Board Act 1998*, S.O.1998, c.15, (Schedule B);

AND IN THE MATTER OF an Application by Enbridge Gas Distribution Inc. for an order or orders approving the clearance or disposition of amounts recorded in certain deferral or variance accounts.

PROCEDURAL ORDER NO. 1 August 5, 2014

Enbridge Gas Distribution Inc. ("Enbridge") filed an application dated June 11, 2014 with the Ontario Energy Board (the "Board") under section 36 of the *Ontario Energy Board Act*, S.O. 1998, c.15, (Schedule B) for an order approving the disposition of balances in certain deferral or variance accounts. The Board has assigned file number EB-2014-0195 to the application.

The Board issued a Notice of Application (the "Notice") dated July 17, 2014. Intervenor status was requested by:

- Building Owners and Managers Association ("BOMA");
- Canadian Manufacturers and Exporters ("CME"):
- Consumers Council of Canada ("CCC");
- Energy Probe Research Foundation ("Energy Probe");
- Federation of Rental-housing Providers of Ontario ("FRPO");
- Industrial Gas Users Association ("IGUA");
- School Energy Coalition ("SEC");
- TransCanada Energy Ltd. ("TCE");
- TransCanada Pipelines Ltd. ("TransCanada");
- Union Gas Limited ("Union"); and
- Vulnerable Energy Consumers Coalition ("VECC").

BOMA, CME, CCC, Energy Probe, FRPO, IGUA, SEC, and VECC applied for cost eligibility. Enbridge did not object to the requests for intervenor status or cost eligibility.

I hereby grant intervenor status to all parties that requested it. A list of intervenors in this proceeding is attached as Appendix "A" to this Order. I have also determined that BOMA, CME, CCC, Energy Probe, FRPO, IGUA, SEC and VECC will be eligible to apply for an award of costs under the Board's *Practice Direction on Cost Awards*.

I consider it necessary to make provisions for the following matters related to this proceeding. The Board may issue further procedural orders from time to time.

THE BOARD ORDERS THAT:

- 1. The parties listed in Appendix "A" are granted intervenor status in the proceeding.
- 2. Board staff and intervenors seeking information and material from Enbridge that is in addition to the evidence filed with the Board, and that is relevant to this proceeding, shall request it by written interrogatories filed with the Board and delivered to Enbridge and intervenors on or before **August 20, 2014**.
- 3. Enbridge shall file with the Board complete responses to the interrogatories and deliver them to the intervenors no later than **September 4, 2014**.

All filings to the Board must quote file number **EB-2014-0195**, be made electronically through the Board's web portal at www.pes.ontarioenergyboard.ca/eservice in searchable / unrestricted PDF format. Two paper copies must also be filed at the Board's address provided below. Filings must clearly state the sender's name, postal address, telephone number, fax number and e-mail address.
