**Re: Wyse Meter Solutions Inc. Unit Sub-Metering License Application
OEB File No. EB-2014-0214
Toronto Hydro-Electric System Limited (“THESL”) Application for Intervenor Status**

By this letter, THESL requests intervenor status in the above-noted proceeding.

THESL is a utility licensed by the Ontario Energy Board (the “OEB”) under License ED-2002-0497 to distribute electricity in the City of Toronto.

As a utility regulated by the OEB, THESL has a substantial interest in the regulation of electricity rates in Ontario, including matters of jurisdiction, substance and procedure. THESL's interests include decisions of the OEB that may affect THESL's operation in the Ontario electricity market. THESL therefore has a direct interest in Wyse Meter Solutions Inc.'s ("Wyse") application to provide unit sub-metering services in Ontario. The nature and scope of THESL's intended participation in this proceeding includes examining the effect of Wyse's application on THESL's operations, particularly its ability to continue distributing electricity to its existing customers in the City of Toronto.

THESL seeks the right to be heard, to appear by or with counsel of its choice, to cross-examine on all subject matters in this hearing that may relate to its interest, to advance evidence on specific matters that are relevant to this proceeding, and to present argument.

THESL requests electronic copies of all pre-filed evidence. THESL further requests to be included in the distribution list for any documents, correspondence or other materials related to this proceeding.
