**NOTICE OF PROCEEDING AND NOTICE OF WRITTEN HEARING  
THUNDER BAY HYDRO ELECTRICITY DISTRIBUTION INC.  
CURRENT RIVER HYDRO PARTNERSHIP  
GENERATION RATES**

The Ontario Energy Board (the "Board") is commencing a proceeding on its own motion under section 19 and section 74 of the *Ontario Energy Board Act, 1998* to determine whether a licence amendment should be granted to Thunder Bay Hydro Electricity Distribution Inc. in order to exempt it from section 3.2 of the Retail Settlement Code (the "Code") in relation to a specific retail embedded generator. Section 3.2 of the Code, in conjunction with Appendix A of the Code, requires that the Hourly Ontario Energy Settlement Price ("HOEP") be used for the purpose of calculating settlement with retail embedded generators. The licence amendment would be necessary if the Board decided to grant approval of the pricing mechanism described within a Settlement Agreement between Thunder Bay Hydro Electricity Distribution Inc. and Current River Hydro Partnership. The pricing mechanism would permit Thunder Bay Hydro Electricity Distribution Inc. to purchase power from Current River Hydro Partnership at a price greater than HOEP.

**Participation**

You may participate in this proceeding in one of three ways:

1. You may send the Board a letter of comment. Your letter must be received by the Board no later than 30 days from the date of this notice or the date of publication of this notice.
2. You may request observer status in order to receive documents issued by the Board in the proceeding. Your request must be made by letter and be received by the Board no later than 10 days from the date of this notice or the date of publication of this notice.
3. You may request intervenor status if you wish to actively participate in the proceeding. Your request must be made by letter of intervention received no

later than 10 days from the date of this notice or the date of the publication of this notice. Your letter of intervention must include a description of how you are, or may be, affected by the proceeding; and, if you represent a group, a description of the group and its membership. The Board intends to proceed by way of a written hearing. The Board will not hold a written hearing if a party satisfies the Board that there is good reason for holding an oral hearing. Your letter of intervention should indicate your preference for a written or oral hearing, and the reasons for that preference. The Board does not intend to provide for costs awards in this proceeding. You must provide a copy of your letter of intervention to Thunder Bay Hydro Electricity Distribution Inc. and Current River Hydro Partnership.
