Please find below responses to each of the incomplete areas identified in your letter dated August 26, 2014.

***“1. Section 1, Page 1 of the Application Form – Name to Appear on Licence
In section 1 of the application form you have identified the legal name of the applicant as NGUTech Inc. and below requested that the name to appear on the licence be ValEnergy Company. The application form notes that if the name to appear on the licence is different from the legal name, the legal name must appear first, e.g. NGUTech Inc., doing business as ValEnergy Company. Please resubmit page 1 of the application form with the proper name to appear on the licence.”***

***“2. Section 7, Page 4 of the Application Form – Intended Services:
In this section you have stated that you are currently providing unit sub-metering services. Section 57(c.1) of the Ontario Energy Board Act, 1998 states that no***

person is permitted to engage in unit sub-metering without a licence. Please explain in details what services you are currently providing and for how long. Please provide reasons for not applying for a unit sub-metering licence earlier to ensure compliance with regulatory requirements.Ontario Energy Board”

Response:

These services are being provided as a Third-Party vendor to OEB licensed companies. We provide Customer Service, Billing and Collections services respond to the OEB and Measurements Canada questions where requested. We developed the systems to support such services. We have provided these services for 3 years. Prior to this venture, we worked for other Third-Party providers servicing licensed entities providing similar services for an additional 4 years.

***“3. Section 8, Page 5 of the Application Form – Corporate Organization:
To help the Board understand your organization, please provide a brief summary of NGUTech’s business activities.”***

Response:

As indicated in the previous response NGUTech provides Third-Party services to OEB licensed companies seeking Customer Service, Billing and Collections services and software.
