



Harper, Mulroney again after X-PM's criticism

TAWA — What had been a renewed political friendship between Stephen Harper and Brian Mulroney could be back on the rocks.

The prime minister found himself offering up a defence Friday in the face of an onslaught of criticism from Mulroney over foreign affairs policy, Canada's relationship with the U.S. and Harper's public fight with the Supreme Court.

On the 30th anniversary of his historic majority election win this week, the 75-year-old Mulroney gestured the Tories weren't in step with Canadian traditions and history because of their strained relationship with the United Nations. He pointed to Canada's last failed bid for a seat on the Security Council as evidence of a bigger problem.

The former prime minister said the government's foreign affairs policy "has to be enveloped in a broader and more generous sweep that takes in Canadian traditions and Canadian history in a more viable way. "We're in the big leagues ... we have to conduct ourselves in that way. We can't outriders," he told CTV's "Power Play."

He also suggested the government had no clout internationally because the current prime minister is close ties to U.S. President Barack Obama. But in Wales for the NATO summit, Harper said Canada's ability to "contribute concretely in international affairs" has never been higher, "whether on the hard-powered side like the military, or the soft we've been doing on development, particularly our leadership on child and maternal health."

Harper severed ties with Mulroney in 2007 over former prime minister's business dealings with man lobbyist Karlheinz Schreiber.

Construction mogul says he gave former police boss \$250,000

MONTREAL — An ex-construction mogul ped a bombshell at Quebec's corruption probe Friday, saying he gave \$250,000 to help Montreal's senior top cop because he was in debt after losing a municipal election.

Jacques Duchesneau immediately dismissed the Accurso's comments as completely false.

Duchesneau campaigned unsuccessfully for the job of Montreal mayor last Pierre Bourque for the city's police chief. Accurso testified at the Charbonneau Commission that he was approached by a man named Richard who was part of Duchesneau's entourage and set up a meeting between the two.

Duchesneau told him even his house was gaged because of his financial difficulties after municipal election defeat.

"Mr. Duchesneau who asked for me," Accurso said. "He said, 'Listen, if you help me, I'll get on my feet somewhere and I'll remember.'" The ex-construction kingpin said he then handed a cheque for \$250,000 but that it was made in the name of Richard's company. Accurso did not remember the man's family name or company.

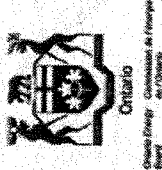
