Regional Infrastructure Planning - Establishing the Regional Planning RE: Standing Committee ("RPSC") - Board File Number: EB-2011-0043

Regional planning of energy infrastructure is increasingly important. With growing concern about the negative impacts of rising energy costs, aging infrastructure and localized increasing demand, a coordinated approach that bridges provincial and local goals is essential. - Other details such as community engagement activities, technical qualification/ experience to be included: Mr. Lupton is active in energy conservation, renewable generation and district energy in Hamilton and fleet and traffic.
- What and how you intend to add value to this committee: Mr. Lupton will represent the interests of AMO and provide his expertise in municipal and energy matters
