LETTER OF DIRECTION

Dear Mr. Lippold:

**Re: Natural Resource Gas Limited Rates Effective October 1, 2014
Board File No. EB-2014-0274**

The Ontario Energy Board has now issued its Notice of Application and Hearing ("Notice") relating to your application seeking approval to extend the current ratemaking framework for another two years effective October 1, 2014. Please note that you must publish the Notice within **fourteen days** of the date of this letter. If publication is not possible within fourteen days, you must inform the Board Secretary immediately.

You are directed:

1. To immediately arrange for the publication of the Notice, in the exact form accompanying this letter, except under the fourth bullet of the section entitled **"BE INFORMED AND HAVE YOUR SAY"**.

- a) remove the bold and bracketed words **"[insert actual date 10 calendar days from publication]"**; and

Insert the actual date, using the following format **"January 1, 2014"**, which date shall be determined by adding 10 calendar days to the date of publication of the newspaper in which the Notice appears. If that actual date falls on a "holiday" as defined in Rule 6.02 of the Board's *Rules of Practice and Procedure*, insert the next date that is not a holiday.

- b) Publication must be made in one issue of a national English-language daily newspaper and one issue of an English language weekly newspaper with the highest circulation in NRG's franchise area.

Please note that invoices regarding publication are NOT to be sent to the Board.

2. Once the publication date is known and the actual date determined in accordance with this letter; to immediately and prior to the publication of the Notice, file with the Board a pdf version of the completed Notice.
3. To immediately, and no later than the date of publication of the Notice, if NRG has not already done so, serve a copy of the Notice, together with a copy of the application, either personally, by courier, or by registered mail on:
 - a. all First Nation Bands and First Nation Reserves to which NRG supplies gas,
 - b. all intervenors in EB-2010-0018, EB-2013-0081 and EB-2012-0406,
 - c. Enbridge Gas Distribution Inc.,
 - d. the Clerks of all municipalities in which NRG supplies gas, and
 - e. Union Gas Limited.
4. To make a copy of the application and evidence, and any amendments thereto, available for public review at NRG's office.
5. To file with the Board an affidavit proving publication and service of the Notice and that a copy of the application, evidence and Notice are available for public review at NRG's office.
6. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
