**IN THE MATTER OF** the Ontario Energy Board Act, 1998, S.O. 1998, c.15, Schedule B (the "Act");

**AND IN THE MATTER OF** an Application by Goldcorp Inc. for an Order under section 36 of the Act directed at Union Gas Limited regarding the quantum of an aid to construct payable by Goldcorp to Union for a gas pipeline that was the subject of EB-2011-0040.

**PROCEDURAL ORDER NO. 1  
(Amended) September 16, 2014**

The Ontario Energy Board received an application from Goldcorp Inc. ("Goldcorp") under section 36 of the Act on July 4, 2014.

The Board previously approved an application by Union Gas Limited ("Union") to construct a natural gas pipeline to serve certain of Goldcorp's mines (EB-2011-0040). There was a delay in the construction which Goldcorp says resulted in additional costs. In the current application Goldcorp is asking the Board to order Union to exclude \$2,375,000 of the additional costs from Goldcorp's contribution in aid of construction for the natural gas pipeline.

An amended Notice of Application ("Notice") was issued on July 28, 2014. In accordance with the Board's directions, the Notice was posted on the respective websites of Goldcorp and Union and served on all intervenors in Union's Red Lake leave to construct proceeding (EB-2011-0040) and on all intervenors in Union's recent rate case proceeding (EB-2013-0365).

Enbridge Gas Distribution Inc. ("Enbridge") has applied and is granted an intervenor status in this proceeding. While Union did not officially apply for intervenor status, because Union is named in the application, was referenced in the Notice and was

directed by the Board to post the Notice on its website, I hereby deem Union to be an intervenor in this proceeding.

A record of all procedural matters that have been dealt with up to this point in this proceeding is available on the Board's web site.

I consider it necessary to make provisions for the following matters related to this proceeding. The Board may issue further procedural orders from time to time.

**THE BOARD ORDERS THAT:**

1. The parties listed in Appendix "A" are granted intervenor status in the proceeding.
2. Board staff and intervenors seeking information and material from Goldcorp that is in addition to the evidence filed with the Board, and that is relevant to this proceeding, shall request it by written interrogatories filed with the Board and delivered to Goldcorp and intervenors no later than **September 29, 2014**
3. Goldcorp shall file with the Board complete responses to the interrogatories and deliver them to the intervenors no later than **October 14, 2014**.
4. Intervenors who wish to present evidence shall file that evidence with the Board and deliver it to Goldcorp and all intervenors no later than **October 28, 2014**.
5. Anyone who requires additional information related to any intervenor evidence, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to Goldcorp and all intervenors on or before **November 11, 2014**.
6. Responses to the interrogatories on intervenor evidence shall be filed with the Board and delivered to Goldcorp and all intervenors on or before **November 25, 2014**.

All filings to the Board must quote the file number, EB-2014-0234, be made electronically in searchable / unrestricted PDF format through the Board's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming

conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.ontarioenergyboard.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
