REVISED PROCEDURAL ORDER NO. 1

Union Gas Limited ("Union") filed an application with the Ontario Energy Board (the "Board") dated January 17, 2006, under section 90 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B). Union has applied for an order of the Board granting leave to construct approximately 29 kilometres of 12 inch diameter steel natural gas pipeline in the unincorporated Gorham Township and City of Thunder Bay. The proposed pipeline will proceed from the existing TransCanada Pipeline Thunder Bay Metering Station located at Concession 4, Lot 6 in the Township of Gorham to the Ontario Power Generation Customer Station located on Mission Island in the City of Thunder Bay. The Board has assigned the leave to construct application File No. EB-2006-0004.

Union also filed an application with the Board, under section 8 of the *Municipal Franchises Act*, R.S.O. 1990, c.M.55, for an order approving a Certificate of Public Convenience and Necessity ("certificate") for the unincorporated Gorham Township. The Board has assigned the certificate application File No. EB-2006-0017.

The Board issued a Notice of Application and Hearing ("Notice") on February 2, 2006. The Notice was published and served by Union as directed by the Board. A list of Intervenor is included as Appendix A to this Order.

In the Notice, it was indicated that the Board may choose to hold either a written or an oral hearing, and prospective Intervenor were requested to indicate their preference in that regard. Several Intervenor requested that the Board proceed by way of oral hearing. Given these requests and the local nature of the project, the Board will proceed by way of an oral hearing in the City of Thunder Bay. The exact date and location of the hearing has not yet been set, however, the Board anticipates holding the oral portion of the hearing in the first half of June.

The Board considers it necessary to make provision for the following procedural matters. Please be aware that further procedural orders may be issued from time to time.

THE BOARD ORDERS THAT:

1. Intervenor and Board staff who wish information from Union that is in addition to the evidence filed with the Board, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to Union on or before Wednesday, April 5, 2006. All interrogatories shall use the reference format of the example in Appendix B to this Order.
2. Union shall file with the Board complete responses to the interrogatories and deliver them to the Intervenor no later than Monday, April 17, 2006.
3. Intervenor who wish to present evidence that is relevant to the hearing shall file that evidence with the Board and deliver it to Union and the other Intervenor on or before Monday, May 1, 2006.
4. Anyone (Intervenor, Board staff or Union) who requires additional information related to any Intervenor's filed evidence, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to the parties on or before Monday, May 15, 2006. Responses to the interrogatories shall be filed with the Board and delivered to Union and the other Intervenor on or before Monday, May 29, 2006. All interrogatories shall use the reference format of the example in Appendix B to this Order.

5. All filings with the Board noted in the Order must be in the form of 9 hard copies and received by the Board by 4:30 p.m. on the stated date. The Board requires all correspondence to be in electronic form as well as in paper copy. In addition to the paper copy, all parties must e-mail an electronic copy of their filings in searchable PDF format to the Board Secretary at boardsec@oeb.gov.on.ca
