Subject: Markham District Energy Inc. Generation Licence# EG-2000-0420

We are requesting an amendment to our generator licence to have three generation facilities under contract with the Ontario Power Authority ("OPA") added to Schedule 1 which are described below. In addition, we have increased the size of Plant#1 from 3.3MW to 3.5MW.

- a) 5.266MW generator facility was completed in 2008 and went into commercial operation under 20 year contract with the OPA for a contracted capacity of 5MW. This is a contract awarded under the OPA RFP Phase 1 offering. This facility is at 8100 Warden Avenue and is next to the existing Warden Energy Centre Plant (referred to as Plant#1 on the licence).
- b) 3 MW generator to be completed end of 2013 under a 20 year contract with the OPA for a contracted capacity of 2.6MW. This contract was awarded in 2011 under the Combined Heat and Power Standard Offer Program. The generator will be installed in the existing Birchmount Energy Centre Plant, 7900 Birchmount Rd, Markham.
- c) 4 MW generator to be completed in Q1 2014 under a 20 year contract with the OPA for a contracted capacity of 3.25MW. This contract was awarded in 2011 under the Combined Heat and Power Standard Offer Program. The generator will be installed in the newly built BurOak Energy Centre Plant, 3211 Bur Oak Avenue, Markham.
- d) Increase in the size of the generator capacity at Warden Energy Centre Plant (Plant#1) from 3.3MW to 3.5MW in 2004.

Further details on the above are provided in the attached schedules along with the OPA contracts. Updated information on the key individuals is also attached.

We wish to have the proceeding disposed of without a hearing in reference to the test set out in section 21 (4)(b) of the Ontario Energy Board Act, 1988. No other person will be

adversely affected in a material way by the outcome of the proceeding. The 5.266MW facility in operation since 2008 received Environmental Compliance Approval ("ECA") from the Ministry of Environment ("MOE"). The two facilities to be completed at a later date are being treated by MOE as an amendment to the facilities existing ECA. These sites are not subject to any form of Environmental Assessment.
