# PROCEDURAL ORDER NO. 1

Canadian Renewable Energy Corporation (the "Applicant" or "CREC") filed an application with the Ontario Energy Board, (the "Board") dated February 2, 2007 under section 92 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c.15, Schedule B. The Applicant has applied for an order of the Board for leave to construct approximately 12.1 kilometres of single circuit 230 Kilovolt ("kV") electricity transmission line, underground and submarine, and associated facilities. The transmission line would extend from a new transformer station ("TS") located on Wolfe Island ("Wolfe Island TS") to a new customer switching station "CSS"), adjacent to Hydro One Networks Inc. ("HONI") Gardener TS. At the CSS, the proposed transmission line will connect with existing HONI 230 kV transmission lines X2H or X4H on the connections to Gardner TS.

The construction of the associated facilities, Wolfe Island TS and the new CSS, is part of the Application. The proposed transmission lines and associated facilities will connect the CREC Wolfe Island Wind Project to the HONI transmission system.

The Board assigned File No. EB-2007-0034 to this application and issued a Notice of Application dated February 23, 2007. CREC served and published the Notice as directed by the Board. The Notice requested that parties indicate their preference for an oral or written hearing. Two parties, Utilities Kingston and Paul Martin Construction Co. Ltd., indicated a preference for an oral hearing. The Board is considering these requests and will determine the type of hearing in a future procedural order.

The Board considers it necessary to make provision for the following procedural matters. Please be aware that further procedural orders may be issued from time to time.

## THE BOARD ORDERS THAT:

- 1. Intervenors and Board Staff who wish information and material from the Applicant that is in addition to the evidence filed with the Board shall request it by written interrogatories filed with the Board, and delivered to the Applicant on or before Monday, April 9, 2007.
- 2. All interrogatories and responses must include a reference to the section of the application which identifies the specific evidence on which the interrogatory is based.
- 3. The Applicant shall file with the Board complete responses to the interrogatories and deliver them to the Intervenors no later than Wednesday, April 18, 2007.
- 4. Intervenors who wish to submit evidence shall, on or before Friday April 20, 2007 so advise the Board and the Board will establish a date for submission and responses, in a subsequent Procedural Order.
- 5. All filings with the Board noted in the Order must be in the form of 9 hard copies and must be received by the Board by 4:45 p.m. on the stated date. The Board requires all correspondence to be in electronic form as well as paper. Therefore, all parties must also e-mail an electronic copy of their filings in accessible, searchable PDF format to the Board Secretary at Boardsec@oeb.gov.on.ca.
