- IGPC Ethanol Inc. and Integrated Grain Processors Co-operative Inc. (collectively "IGPC") are the owners and operators of a 150 million liter per year ethanol facility on the Town of Aylmer, within the franchise area of Natural Resource Gas Limited ("NRG").
- 2. IGPC seeks full status of an intervenor in this proceeding and reserves its rights to file evidence, cross-examine witnesses, make submissions, and generally fully participate in this proceeding. Specific relief has been sought by NRG regarding IGPC which it opposes. As such IGPC is directly impacted by the Application.
- IGPC is the largest customer within NRG's service territory contributing approximately 30% to NRG's total distribution revenue. IGPC's gas purchases constitute approximately 60% of NRG's entire system load. IGPC notes that it is a co-operative whose membership includes many ratepayers of NRG.
- 4. IGPC requests a written interrogatory process followed by an oral hearing. An oral hearing will be required to fully explore the impact of this Application and test the evidence.
